### **Guest Speaker**

LEE TAFANELLI joined Kansas

Electric Cooperatives, Inc. as CEO in May 2020. Tafanelli most recently served

as the Kansas Adjutant General, responsible for three primary duties: ensuring the wartime readiness of over 7,000 soldiers and airmen of the Kansas Army and Air National Guard, coordinating the overall emergency preparedness for the state's response to natural disasters and emergencies, and serving as the Homeland Security Advisor for the state of Kansas.

Tafanelli served in the Kansas House of Representatives from 2001-2005, when he took a leave from office to command the 891st Engineer Battalion in Iraq. After his deployment, he resumed his legislative post in 2006 where he served until January 2011, when he was appointed Kansas Adjutant General. During his time in the Kansas Legislature, Tafanelli developed a deep interest on issues affecting rural Kansas. Tafanelli received his commission from Pittsburg State University, Army Reserve Officer Training Corps, and holds a master's degree in environmental planning and management from Kansas State University and a master's degree in strategic studies from the U.S. Army War College. Throughout his military career, he has received numerous military awards including the Army Distinguished Service Award and the Bronze Star Medal.



A meeting of the Lane-Scott Electric Nominating Committee was held on Monday, June 6, 2022, at 6:30 p.m. in the office of the cooperative at 410 S. High Street in Dighton.

Members of the nominating committee present were Lex Bush representing Lane and Gove counties; Randy Scheuerman and John Beaton representing Logan and Scott counties; Lane Copeland and Kenneth Schlegel representing Ness and Rush counties; and Doug Vieux and Dan Wehkamp representing Finney and Hodgeman counties. Also attending were attorney Joseph Gasper and General Manager Richard McLeon.

By vote the committee nominated the following individuals to be elected by the members at the annual meeting of members:

- ▶ RAD ROEHL for the position of trustee representing Lane and Gove counties.
- ► CHAD GRIFFITH for the position of trustee representing Scott and Logan counties.
- ▶ **ERIC DOLL** for the position of trustee representing Finney and Hodgeman counties. The meeting adjourned at 6:43 p.m.

## **Executive Report**

The year 2021 began with optimism. 2020 and its coronavirus-related mandated quarantines, store closures and isolation were behind us. We discovered the travel restrictions, which shut down automobile and air travel, led to cleaner air in most cities. Quarantines and store closures brought families together for meals and game nights. Isolation from loved ones reminded us how precious those relationships can be.

Sustainability became the mantra of a new era reflecting everything from power supply to emissions, to personal relationships. The worst was behind us, and we looked to 2021 with optimism.

Then it was February. Feb. 14 to be specific. Record-breaking cold swept across the central United States as Winter Storm Uri made its presence felt. The storm delivered an unprecedented and prolonged arctic wave of freezing temperatures, ice and snow to the central and eastern regions of the U.S. Everything from the northern U.S. border to Mexico was affected.

Demand peaked as homes and electric generating facilities competed for natural gas, driving prices to all-time highs. Power plants tripped off and the Southwest Power Pool ordered load sheds for the first time in its 81-

year history. Suddenly Dighton, Ness City, and parts of Finney County found themselves plunged into darkness as the temperatures dropped to -20F. Thankfully, the forced outages only lasted a few hours, and the grid was restored, but the fuel-driven cost of wholesale power had increased to almost six times that of average costs.

Our immediate concern was to lessen the financial impact of Winter Storm Uri on our members and in March 2021 the board approved a three-year loan from CoBank to cover the added costs. All Lane-Scott members were given a 42-month, interest-free option for any energy usage above the average billing. By the end of 2021, over half of our members had paid back their original Winter Storm Uri billings.

Your cooperative progressed through the year as COVID-19 waned and our new Generac home generator product offering gained steam. Interest rates, fuel and material costs began to rise so we watched our pennies, and, as always, the dollars followed.

Amid these challenging times, Lane-Scott Electric Cooperative maintained the fifth lowest residential rate among Kansas cooperatives, about 18% below the local municipal rates — all while keeping your dollars local and remaining financially strong. We stayed focused on our core business of providing reliable, cost-effective power

and finished 2021 with \$59,930,131 in utility plant with a total of \$35,286,431 in long-term debt. The cooperative had \$18,976,716 in energy sales and an operating margin of \$393,295, (a "surplus" of around 2.1%).

The Merriam Webster dictionary defines the word cooperative as:

- Mutual assistance in working toward a common goal.
- A farm, business, or other organization which is owned and run jointly by its members, who share the profits or benefits. Cooperatives are non-profit. That's the way we were founded and that's the way we continue to operate. If we make more than we need, we pay it back to you, our owners. I am very happy to report that last year the cooperative returned \$451,140 of equity to members in our largest capital credit retirement in many years.

Unfortunately, the year ended as it started, and on Dec. 15, 2021, a massive windstorm with wind gusts of up to 105 mph raced across most of Kansas. Poles broke and wildfires started in the high wind and drought conditions. Lane-Scott lost hundreds of poles as 1,540 members lost power. Our crews worked long hours, alongside other cooperatives, to restore power as quickly as possible.

We never know what the future holds, but we know that as a cooperative we are



stronger together as we work toward our common goal of keeping the lights on and the costs reasonable. We continue our commitment to our communities and to keeping local dollars local while we investigate new technologies and efficiencies to keep your rates affordable and your reliability high.





# Sharing Success in the

Through a partnership with CoBank, one of our national partner banks, Lane-Scott began the CoBank Sharing Success Grant Program in 2020. The program is designed to provide grants to charitable organizations and causes in our local communities.



CoBank is a national nonprofit

cooperative bank owned by the rural American cooperatives it serves. Since the Sharing Success Program was established in 2012, CoBank and its customers have together contributed more than \$50 million to groups such as volunteer fire departments, local schools, and hunger relief programs to name a few. In 2021, CoBank matched Lane-Scott Electric's \$2,000 donation awarding four recipients each with a \$1,000 grant.

The 2021 recipients were: **FRANK STULL AMERICAN LEGION AUXILIARY**, to install a handicap ramp in the American Legion and Auxiliary meeting room; **LANE COUNTY LIONS CLUB** enhanced their signature program providing meals to the youth

and homebound adults of Lane County; **NESS COUNTY FIRE DISTRICT NO. 1** for firefighting equipment; and **WESTERN KANSAS CHILD ADVOCACY CENTER** to help purchase education and prevention resources. These grants were distributed in July 2021.

Applications are accepted at the beginning of each calendar year from 501(c) (3) non-profit organizations, and other organization's such as schools, government organizations like counties, municipalities, and their agencies or departments. Use of the grants must serve a public purpose and benefit a community or communities that receive electric service from Lane-Scott or whose purpose benefits our members.



# 2021 Annual Meeting

The 2021 Annual Meeting of the Members of Lane-Scott Electric Cooperative, Inc. was held on Tuesday, July 20, 2021, at the Lane County Fairgrounds in Dighton, Lane County, Kansas. The meeting commenced at 7:52 p.m., pursuant to notice mailed to all members in accordance with the bylaws of the cooperative.

The meeting was called to order by President Richard Jennison. President Jennison welcomed those in attendance and introduced guests including Tom Ruth and Nolan Numrich of Western Cooperative Electric; Alan Westfall of Stanion Electric; Doug Shepherd of Kansas Electric Cooperatives, Inc. (KEC); Jim Minnix, Kansas Representative. Sunflower Electric Power Corporation was represented by Stuart Lowry, Clare Gustin and Annie Erbert.

President Jennison next introduced the members of the board of trustees, general manager and legal counsel.

Joseph Gasper, legal counsel, certified notice of the annual meeting was mailed to members at each members' address as it appears on the records of the cooperative and reported 143 members were in attendance constituting a quorum.

President Jennison referred the members to the printed minutes of the 2020 annual meeting appearing in the notice of the annual meeting. On motion duly made, seconded, and carried, the reading of the minutes of the 2020 annual meeting was waived and the minutes were approved as printed.

President Jennison referred the members to the printed treasurer's report. On a motion duly made, seconded, and carried, the reading of the treasurer's report was waived, and the treasurer's report was approved as printed.

President Jennison recognized Lane-Scott employees and thanked them for their hard work.

Michael Pollock and Chris Terhune were recognized for their 15 years of service. Kathy Lewis was recognized for her 30 years of service.

Manager McLeon announced the winners of the 2021 Continuing Education Scholarship as follows: Kaden Bradstreet, Kyle Doll, Alysson Foos, Patrick O'Toole, Eli Rupp and Kiley Whipple. The scholarships were awarded in the amount of \$1,500 this year due to cancellations of the Electric Cooperative Youth Tour to Washington, D.C. and Cooperative Youth Leadership Camp.

The Dighton KidWind BTU Crew consisting of Cordell Davis, Hank Davis, Westin Johnson and Charlie Vogel were introduced. They won the state competition, and competed and received recognition at the national competition for their turbine named "Patricia." The young men made a presentation of their turbine design and construction.

Manager McLeon presented his manager's report with highlights as follows:

ightharpoonup 2020 was a difficult year due to the pandemic and natural disasters.

# **Minutes**

- ▶ Energy sales fell by \$1.7 million for the year, which required decreasing expenses to compensate.
- ▶ Rates remained 16% below the state average.
- ► The office was temporarily closed for part of the year and technology was used to allow employees to work remotely.
- ▶ Care packages were sent to military servicemen from the service territory.
- ▶ Customer satisfaction for Lane-Scott was 89% according to an independent survey.
- ▶ Winter Storm Uri in February caused significant disruption to the power grid. Natural gas prices spiked, which resulted in high electric charges as well. The average monthly power cost is approximately \$750,000 which spiked to \$4 million in February. The additional cost recovery is being collected from members over 42 months unless they wish to pay it off in a lump sum.
- ▶ Despite the difficulties in 2020, Lane-Scott remains financially sound. President Jennison then called for additional registrations. There were no additional registrations.

President Jennison introduced the guest speaker, Doug Shepherd, vice president of management consulting services at KEC and asked him to speak. Highlights of his presentation are as follows:

- ▶ KEC consists of 30 electric cooperatives.
- ▶ KEC is celebrating its 80th anniversary this year.
- ▶ KEC works with its member co-ops to assist with various cooperative issues, mutual aid and working with legislators on cooperative matters.
- ▶ The *Kansas Country Living* magazine is published by KEC and is a cost-effective way for Lane-Scott to communicate with its members.
- ▶ KEC provides educational opportunities for Lane-Scott staff and trustees as well as providing safety training and regulatory compliance.
- ▶ Lane-Scott was incorporated in 1941 becoming active in 1946 with the purchase of the Healy municipal system. A generator was purchased in 1949 and in 1952 service to Dighton was begun.

Attorney Gasper presided over the election of trustees and proposed bylaw amendments. The members of the nominating committee met and submitted names of the following individuals as nominees for three trustee positions: Richard Jennison and Sara McWhirter, to represent Lane and Gove counties; Craig Ramsey, representing Scott and Logan counties; and Harold Hoss, representing Ness and Rush counties.

Attorney Gasper called for additional nominations. There were no additional nominations.
