

Official Notice of Annual Meeting

Executive Report

The year 2024 ended with a welcome return to near-normal operations following challenges of the post-COVID economy and uncertain economic policies that threatened to affect grid reliability.

Our strategy has been to evaluate in-house processes, eliminating what doesn't work and finding alternatives that do. We continue to harden our system and implement new technologies to improve reliability and manage inventories to run efficiently. We are focusing on employee training and team building, with an eye on the future.

As a non-profit electric cooperative, the sole reason we exist is to serve you with reliable, affordable electric energy and related cooperative services. To accomplish that mission, our focus remains on three things: rates, reliability and safety.

RATES

We purchased 177,120 megawatt-hours of wholesale electricity from Sunflower Electric Power Corporation in Hays and delivered it to you at cost. Wholesale power costs per kilowatt-hour increased by 8.7% and wholesale power cost accounted for 53.7% of your total power bill.

We reviewed our utility rate structure in April 2024 allowing us to leverage Lane-Scott system load profiles and revise our rates to deliver a total net cost per kilowatt-hour reduction of 2.92%. That may not sound like much, but in the challenging 2024 U.S. economy

and inflationary times, we were able to produce an average savings of \$94.67 per member per year.

RELIABILITY

Cheap power doesn't mean much if the lights aren't on. Lane-Scott tracks several utility industry standard reliability metrics. Our system average service availability index (ASAI) for 2024 was 99.92% while the average number of interruptions per meter (SAIFI) was 1.1 per meter.

Power interruptions can be separated into two general categories: those we cannot control (major storms and wholesale supplier outages) and those we can control or at least minimize with system hardening. Last year 91.6% of our system outages resulted from major storms and power supplier disruptions that we have no control over. The rest, 8.4% or 33.7 minutes per meter, were the result of minor storms, animals and other common disruptions.

SAFETY

Employee and community safety is always first in our thoughts. We continue to expand and improve our internal safety processes, training, equipment, and documentation. We partner with Kansas Electric Cooperatives, Inc. to offer employees timely and interesting safety content at required monthly safety meetings. All linemen are trained in pole top rescue, first

aid, CPR, and in safety inspections and observations. Crews are required to conduct "tailgate" safety briefings before every job.

Our commitment to safety extends beyond our employees. The Lane-Scott Electric Cooperative offers high-voltage safety education in our communities at no charge. This year, we were able to complete our own high-voltage safety demonstration trailer. Having this valuable tool helps us better serve community members of all ages and occupations with electrical safety education. We offer these services because protecting our most valuable resources, our employees and our community, is simply the right thing to do.

The bottom line is that your cooperative stayed focused on our core business of providing reliable, cost-effective power safely and finished 2024 with over \$64 million in utility plant with a total of \$35 million in long-term debt. The cooperative has 23 employees serving all or part of eight central, western Kansas counties with over 2,000 miles of energized power line.

Non-operating margins had its best year in a while with the good folks in financial services managing our investments and adding over \$400,000 in interest earnings to the bottom line. Cooperative services including Generac generator sales and servicing, master electrician services, electrical parts and equipment sales added almost \$79,000 to the bottom line.

The Merriam Webster dictionary defines the word cooperative as:

- ▶ Mutual assistance in working toward a common goal.
- ▶ A farm, business or other organization that is owned and run jointly by its members, who share the profits or benefits.

Cooperatives are non-profit. That's the way we were founded and that's the way we continue to operate. If we make more than we need, we pay it back to you, our owners.

We are very happy to report that last year the cooperative returned a record high \$591,000 to members bringing our total retirement to \$1,933,338 over the past four years. That represents 40.9% of the total \$4,728,911 that your cooperative has returned in the lifetime of The Lane-Scott Electric Cooperative.

One of our most valued of the seven cooperative principles is Cooperation Among Cooperatives. Cooperatives nationwide serve their members most effectively and strengthen the cooperative movement by working together through local, national, regional and international structures.


In the event of disasters, cooperatives rally their available crews to assist those who request mutual aid. This past year, Lane-Scott both received assistance following summer windstorms, and answered the call in South Carolina following Hurricane Helene and in Bentonville, Arkansas, after deadly tornadoes and straight-line winds.

Every day we work toward our common goal of keeping the lights on and your costs reasonable. We continue in our commitment to our communities and to keeping local dollars local while we investigate new technologies and efficiencies in workflow management, electric vehicle charging, distributed energy support, microgrids and demand side management options.

We are 23 employees strong; one cooperative in two convenient locations, and we are honored to be a part of The Lane-Scott Electric Cooperative family and to work alongside these great and dedicated individuals, serving you, every day.

Feeds working to provide and sell show and specialty feeds through a growing dealer network in the Western Kansas and Eastern Colorado territories.

Zach graduated from Kansas State University with a degree in Animal Sciences & Industry and has always been passionate about supporting rural communities and the livestock industry. Over the years, Zach has served on several boards, including two three-year terms on the Beef Empire Days board, where he took on leadership roles as both president and vice president. Mutual Aid in

Lane-Scott crews volunteered for mutual aid efforts following major disasters in 2024.

Cooperation Among Cooperatives is one of the most treasured values all cooperatives have. It's because cooperatives know, at some time or another, they may need assistance from others. Be it ice storms, wind, hurricanes, tornadoes or floods, the priority

is to restore power to members as quickly as possible. Electric cooperatives understand this and are happy to help others when the time arises.

In May 2024, deadly tornadoes and straightline winds left a path of destruction in Arkansas leaving around 68,000 people without power. Crew Leader Ben Mann, along with journeymen linemen Blake McVicker and Dellon Shelton, and apprentice lineman Taylor Cable answered the call to help.

Following Hurricane Helene, journeyman linemen Chad Rupp and Blake McVicker traveled to South Carolina to assist Aiken Cooperative rebuild their system. Fifteen cooperatives throughout Kansas sent over 80 linemen and equipment. Aiken Cooperative reported 92% of their system was without power during the peak of their outages.

Lane-Scott Electric 2024 Capital Credits Retirement

Lane-Scott Electric retired almost \$591,000 in capital credits to members in 2024.

As a not-for-profit electric cooperative, we believe in giving credit where credit is due — to the members who shape our co-op. One of the ways we do this is through capital credits. Because Lane-Scott operates at cost, we give cash back to our members rather than outside investors or shareholders.

HERE'S HOW CAPITAL CREDITS WORK:

Lane-Scott tracks how much electricity each member purchases from the co-op over time. Lane-Scott pays all operating expenses throughout the year, and if any operating revenue is leftover, we allocate it as capital credits. When financial conditions permit, the co-op's board of trustees vote to pay capital credits back to the members. Lane-Scott sends you a check or applies a credit to your energy bill.

This year we returned \$591,000 to members who had electric service with us in 1999 and 2000, totaling over \$1.9 million returned the past four years!

Capital credits are just one of the many benefits of co-op membership. Giving back to our local members instead of outside parties is one of the many aspects that set cooperatives apart from other business entities.

2024 Annual Meeting Minutes

The 2024 Annual Meeting of the Members of Lane-Scott Electric Cooperative, Inc. was held on Tuesday, July 16, 2024, at the Lane County Fairgrounds in Dighton, Lane County, Kansas. The meeting commenced at 7:32 p.m., pursuant to notice mailed to all members in accordance with the bylaws of the cooperative.

The meeting was called to order by President Richard Jennison. President Jennison welcomed those in attendance and introduced guests including Jim Minnix, Kansas Representative; Mindy Pfannenstiel of Kansas Electric Cooperatives, Inc. (KEC); Sunflower Electric Power Corporation was represented by Steve Epperson, Davis Rooney, Jeremy Anderson, Diane Stiles, Nikki Pfannenstiel, Melissa Hubbard and Annie Erbert; Wanda Gable, Ness City Clerk; Alan Westfall of Stanion Electric; Dr. Bill Clifford, Kansas Representative and Janet Shapland, Dighton City Council Member. Lane-Scott retirees recognized were Alan Scott and Stan Bray.

President Jennison introduced the members of the Lane-Scott Board of Trustees, general manager and legal counsel.

Dr. Bill Clifford introduced himself and announced he is running for the 39th district seat.

Joseph Gasper, legal counsel, certified notice of the annual meeting was mailed to members at each member's address as it appears on the records of the cooperative and reported 130 members were in attendance constituting a quorum.

President Jennison referred the members to the printed minutes of the 2023 Annual Meeting appearing in the notice of the annual meeting. On motion duly made, seconded and carried, the reading of the minutes of the 2023 Annual Meeting was waived and approved as printed.

President Jennison referred the members to the printed Treasurer's Report. On a motion duly made, seconded and carried the reading of the Treasurer's Report was waived and the Treasurer's Report was approved as printed.

President Jennison recognized the Lane-Scott employees and thanked them for their hard work.

Nate Burns and Kalo Mann were recognized for their service of 30 years with Lane-Scott Electric. Kalo Mann was further recognized for his retirement from Lane-Scott Electric.

Retiring board member Harold Hoss was recognized for his retirement and service on the board for 39 years. Rad Roehl was recognized for his 15 years of service on the board of trustees.

Manager McLeon recognized the winners of the 2024 Continuing Education Scholarship Recipients as follows: Cally Cramer, Carlee Flax, Lakin Getz, Kalo Hineman, Lillian Payne and Ayden Whipple.

Manager McLeon introduced the 2024 Electric Cooperative Youth Tour attendees, Brooke Henning and Breanna Berndt and asked them to speak about their experience in Washington, D.C.

- Manager McLeon presented his Manager's Report with highlights as follows:
- Lane-Scott employees were recognized for their hard work for the cooperative.
- ▶ An executive report containing cooperative updates and financial metrics was contained in the annual report booklet sent to members.
- ▶ The last three years have been challenging with rising costs of supplies. Regulations are constantly changing as well, which are often at odds of the cooperatives goal of safe, reliable and affordable electricity for its members.
- ▶ The comprehensive safety program remains a priority with the support of the board of trustees and assistance from KEC. Lane-Scott had no loss time days in the prior year for the third time in ten years.
- ▶ Reliability of the system remains a priority. Iron poles are being used in some areas for increased strength. Pole inspections, mapping upgrades and communication improvements have all helped to improve system reliability. Last year, outage hours were the lowest they've been in the past 15 years.
- ▶ Lane-Scott residential rates are 15.4% below the state average and the fifth lowest in the state for all cooperatives.
- ▶ The Seven Cooperative Principles which are Open and Voluntary Membership, Democratic Member Control, Member's Economic Participation, Autonomy and Independence, Education, Training and Information, Cooperation Among Cooperatives and Concern for Community were reviewed as well as how Lane-Scott follows each of these core principles.

President Jennison introduced the guest speaker, Doug Sandridge, vice president of Fulcrum Energy Capital Funds and asked him to speak. Highlights of his presentation are as follows:

- ▶ Doug has been an oil and gas executive for 42 years with his first experience after college in the Hays region.
- ▶ He has been involved in the energy field for his entire career most of in the oil and gas side. He has recently become more interested in electrical energy and has been writing and speaking as an advocate for all energy.
- ▶ Many energy policies are promulgated by people who know very little about energy and he is trying to provide information on energy to those decision makers.
- ► Examples of prominent politician statements regarding energy policy were given and discussed and compared with factual analysis.
- ▶ The world is in an energy transition at this time and there is much uncertainty regarding how the energy sector will look in the future.
- ▶ There has been a push for more renewable energy, but the reality is that nonrenewable energy has grown as well, as demand for energy continues to increase.

▶ The recent Supreme Court decision overruling the Chevron defense will help the energy sector challenge detrimental regulations.
